Ecophos signs EUR 131,000,000 term loan and revolving facilities with senior lenders and EUR 15,000,000 subordinated loans with subordinated lenders

Louvain-La-Neuve - 7 November 2018

Ecophos group is pleased to announce that it has signed an agreement for a EUR 131,000,000 term loan and revolving facilities (the "Senior Facilities") on 31 October 2018 to refinance the group's existing indebtedness as well as ensure revolving credit facilities and term loan facilities for the group's financing needs for the next five years. ING Bank N.V. was mandated to arrange and coordinate the Senior Facilities.

Ecophos group also obtained subordinated loans in an amount of EUR 15,000,000 (the "Subordinated Loans") to reinforce the quasi-equity of the group and facilitate the closing of the Senior Facilities.
